CREDIT SUISSE GROUP AG NOTIFICA REDUÇÃO DE PARTICIPAÇÃO QUALIFICADA NA EDP

Lisboa, 30 de Janeiro de 2019: Nos termos e para os efeitos do disposto no artigo 244º do Código dos Valores Mobiliários e do Regulamento n.º 5/2008 da CMVM, a EDP — Energias de Portugal, S.A. ("EDP") vem prestar a seguinte informação ao mercado e ao público em geral:

No dia 28 de Janeiro de 2019, a Credit Suisse Group AG comunicou à EDP, nos termos do artigo 20.º do Código dos Valores Mobiliários (CVM), que detém uma participação qualificada de 0,76% do capital social e dos direitos de voto da EDP. O patamar de 2% foi ultrapassado no dia 22 de Janeiro de 2019.
